**Exhibit Booth Rules & Regulations**

**Deadlines:** The postmark deadline date for exhibit booth application is March 1, 2013.

**Sorry, we will not be able to accommodate those without advance Registration.**

**Booths:** Only one organization is permitted per booth. Each booth will be provided with an 8-foot table, tablecloth, two chairs, and a canopy.

**Insurance:** The National Foundation for Autism Research, the San Diego Race for Autism and Balboa Park will not be liable for any theft or damage to an exhibitor's property or personal possessions. All exhibitors are advised to carry their own insurance.

**Damage:** No part of any exhibit or related sign may be pasted, nailed, taped, tacked, stapled, or otherwise attached to walls, Park structures or trees. Exhibitors may not obstruct or hide other exhibit areas. **Balboa Park prohibits use of balloons.**

**Set-Up Time:** We would like Exhibitors to set up by no later than 7:30 AM. Race registration begins at 6:45 AM.

**Breakdown: time:** No earlier than 10:30 AM and no later than 12:00 noon.

**Booth Rules:** All exhibitors agree to:

- 1) Comply with the conditions under which exhibit space in Balboa Park is leased to the National Foundation for Autism Research. Note: **Fundraising activities** of any kind are not permitted at the San Diego Race for Autism and Resource Fair.
- 2) Change an assigned space if, in the opinion of the National Foundation for Autism Research, it becomes necessary to change the original space assigned;
- 3) Understand that food and beverage products may not be sold at this event. Complementary food must be individually wrapped.
- 4) Understand that, upon acceptance of the exhibit application form by the National Foundation for Autism Research, a contract between the exhibitor and the National Foundation for Autism Research is in full force and effect.
